Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

TRANSFER OF REMAINS TO FUNERAL HOME (Within Sacramento County).....\$ 555.00*
A price list is available for removals outside Sacramento County.

EMBALMING..... \$ 675.00*
Embalming is not required by law except in certain special cases. Embalming may be necessary. However, if you select certain funeral arrangements such as a funeral with viewing, it is necessary. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial.

OTHER PREPARATION OF BODY

- A. **Dressing, Cosmetics and Casketing..... \$ 475.00***
- B. **Shelter of Remains/Refrigeration (per day)..... \$ 105.00**

California law requires refrigeration after 24 hours if remains are not embalmed.

SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$1545.00*

This is a basic fee that we charge every family for our professional expertise in assisting them with their preferences. Our charge includes, but is not limited to, consultation with the family; administrative and clerical services; preparation of the death certificate signed by the attending physician or coroner; necessary permits; filing the death certificate with the appropriate government agencies; coordinating with clergy, cemetery, crematory or common carrier; assisting with union or insurance papers; planning the funeral or memorial services; ordering flowers or programs; and directing and supervising the service as determined by the family.

This basic fee also incorporates a basic facility charge which is a proportionate share of overhead expenses such as taxes, licenses, utilities and business expenses necessary to serve the public. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements that you select. (This fee is already included in our charge for direct cremations, immediate burials and forwarding and receiving remains.)

VISITATION WITH CREMATION.....\$ 2675.00

These charges include local removal of remains, necessary service of staff, embalming, dressing, cosmetics, visitation for two hours from 1:00-3:00 P.M. in one of the state rooms, and cremation. No substitutions or deletions. Casket not included.
